#### **Communications from the Public**

Member Parker asked for clarification to a comment made regarding a vaccine passport for NCMH.

- Is it a requirement to tell Human Resources (HR) that you have been vaccinated?
  - You are not required to tell HR you have been vaccinated, if you don't tell HR,
    NCMH assumes you have not been vaccinated.
- When are these rules going to go away?
  - This is the current guideline that was issued at the end of May from MDHHS and the CDC for health care facilities.
  - Staff have to wear masks in areas with clients whether they have been vaccinated or not.
  - In staff only areas the vaccinated do not have to wear a mask if they have provided proof to HR. This is voluntary.

Member Kellerman congratulated Jeff Labun on receiving his Master's degree.
