#### Mid-State Health Network (MSHN)

Member DeLaat reported on the following:

- The board chair had a moment of silence for former member Mike Hamm.
- Staff continue to work primarily at home.
- Reviewed Director Sedlock's evaluation; overall it was a positive evaluation.
- 38% reduction in the Block Grant, which will be about 5.2 million dollars. An internal task force will make recommendations on where the cuts need to be made.

### **Community Mental Health Association (CMHA)**

Member Kellerman reported on the following;

- Director Sheehan's evaluation was reviewed; overall it was a positive evaluation.
- Working on revising bylaws. Recommendations are:
  - o keeping the current officers in place through 2021
  - o extended job requirements for the past presidents. Past presidents would be responsible for the history of CMHA and be available to answer questions.
  - Change responsibilities of Treasurer. As of now, that position/person is completely responsible if there is an issue with the budget. That position only should be responsible for reporting to the Board of Directors.
- There is a vacancy on the Board of Directors due to Member Hansen's departure. This vacancy can be filled from any of the CMH's from our region. If any of NCMH's Board of Director's are interested please let Member Kellerman know and she will pass the information along.
- There are five law enforcement agencies that CMHA participates with.
- Legislative bills that are being watched from Lame Duck: Mental Health First Aid kit
  as part of teacher certifications; tele health should be reimbursed as face to face; phase
  out local match down is the same as last year; peer services billable through Medicaid.
- Supreme Court will allow virtual meetings through December 31, 2020.
